Raine Silverstein is the beneficial owner of 4,076,880 shares of Common Stock of the Company, representing 15.3% of the total number of shares outstanding as of February 3, 2003. Mrs. Silverstein (i) has the sole power to vote or direct the vote and to dispose or direct the disposition of 156,000 of such shares, (ii) has shared power to vote or to direct the vote and to dispose or direct the disposition of 3,412,880 of such shares held by Mrs. Silverstein as custodian or trustee for the benefit of Mrs. Silverstein's children and grandchildren, and (iii) may be deemed to have shared power to vote or to direct the vote and to dispose or direct the disposition of 508,000 of such shares held by Mrs. Silverstein's husband.
